VISITOR GUIDELINES

We're excited to welcome you to DelVal—in person—to see for yourself what life is like on campus. To ensure the health and safety of the Delaware Valley University community and our visitors, we have put in place the following measures based on public health directives from the Commonwealth of Pennsylvania and CDC:

BEFORE YOUR VISIT

We require all visitors to register in advance of arriving on campus. To register for a campus tour, go to **delval.edu/visit**. To limit the number of guests on campus, we are **limiting all families to three members**: the prospective student, and two guests. We will not be able to accommodate walk-in visitors due to space and social distancing guidelines. We welcome guests from areas outside of Pennsylvania and ask that before you travel, that you take a quick look at any pertinent guidance from <u>PA Department of Health</u> guidance on travel.

FACE COVERINGS & HYGIENE

You and your guests are **required to bring a face covering** to wear when visiting campus. Face coverings should cover both your nose and mouth, including masks without an exhalation valve and face shields. Face coverings should be worn at all times, especially when physical distancing of six feet or greater is not possible.

Our public restrooms will be available for use. We strongly encourage abiding by public health guidelines, including washing your hands with soap and water for 20 seconds, or using hand sanitizer.

Bottled water will be available when you check in. If you're a coffee or tea drinker, plan on bringing your own to campus. And while we eagerly anticipate meeting you in person, our admission staff will not be shaking hands out of an abundance of caution—please don't be offended.

CHECK FOR COVID-19 SYMPTOMS

We ask you to perform a COVID-19 symptom assessment before arriving on campus. Please refrain from visiting campus if you do not feel well or if you have been in contact with someone who has contracted COVID-19. Additionally, when you arrive to campus we will perform a temperature check as well as a brief symptom assessment as we welcome you.

ON THE DAY OF YOUR VISIT

On the day of your scheduled campus tour, please checkin at the **Life Sciences Building** no more than 10 minutes prior to your visit time. Additional information on arriving to campus will be included in your confirmation and reminder emails.

Tour groups will be limited to **two families per tour guide**. For the safety of our campus community, residence halls will not be shown on tours and we are limiting the number of interior buildings that tour groups will enter. Some of the outside areas that will not be available include: the equestrian center, South Campus farms, small animal science labs and the greenhouses.

We will be providing an in-person admission presentation in our auditorium within the Life Sciences Building. We will have assigned family seating in order to allow for maximum social distancing. If you would like to speak with a counselor at the conclusion of your tour, meetings will be conducted outside or in a large conference room, depending on availability. For high school seniors with specific questions, we strongly encourage registering for a virtual interview at **delval.edu/visit**.

Please be reminded that you are undertaking your visit at your own risk. While Delaware Valley University is taking all precautions to safeguard our community, we cannot eliminate the risk of COVID-19 exposure and infection on campus. Please note that our staff will be temperature screened and symptom checked on a daily basis.
